### 1. Grant of Rights

As a condition of publication, and for complimentary copies of the periodical and no monetary compensation, Author hereby grants and assigns non-exclusively to ISTE the following rights to the Work:

- A. Worldwide rights to reproduce, distribute, perform, sell and display the Work, or any part thereof, in any medium or form of communication or derivative work now existing or hereafter developed.
- B. The right to license any or all of the above rights to a third party.
- C. The right to claim the copyright to the Work in the foregoing rights in ISTE's name, as well as all rights granted to author under the copyright laws of the United States, foreign countries, and international copyright conventions.
- D. The right to use Author's name, likeness, and biographical information to promote the Work.

### 2. Failure to Publish

If the Work is not published, manufactured, or otherwise prepared and offered to the public or licensed to a third party for these purposes within two (2) years of the submission of the Work to ISTE, all rights conferred herein to ISTE shall revert to Author.

### 3. Reversion of Rights to Author

Upon termination of this Agreement under any of its provisions and receipt of a written request by Author, ISTE will grant to Author all rights to the original Work that this Agreement grants to ISTE. The following exception shall apply to this provision:

ISTE will continue to retain such rights to the Work as are reasonably necessary for ISTE to fulfill written contractual or other legal obligations and to receive proceeds from such obligations that exist at the time of termination.

#### **4. Author's Use of Work**

- 4.1 After publication of the Work, and upon Author's written request, ISTE will grant Author royalty-free permission to reprint portions of the Work in other publications, subject to Author including the original copyright notice in the publication. - 4.2 Author warrants the following:
- A. Work originated with Author.
  - B. Author is the exclusive (where relevant) author of the Work.
  - C. Work is not subject to any existing copyright agreements.
  - D. Author has authority to grant the rights in this Agreement.
  - E. Publication will not infringe on or invade the rights of others.
  - F. Author has the full power to make this Agreement.
- 4.3 Each Author retains the following rights:
- A. All other proprietary rights except copyright and the publication rights transferred to ISTE.
  - B. The right to post the ISTE-published version of the article on the Author's own Web site, the right to provide photocopies to colleagues, and the right to reuse any portion of the Work without fee in future works of the Author's own provided that the following citation appears with the appropriate periodical name, volume and issue numbers, and copyright year:

#### **5. Indemnification**

Author will indemnify and hold harmless ISTE and its staff, directors, and officers from any and all losses, damages, or claims arising from any breach of any of the warranties made in this Agreement.

#### **6. Entire Agreement**

This Agreement is the entire Agreement between the parties, and shall remain in force for the life of the copyright or until and unless it is terminated by agreement of all parties and/or for any reason described in its provisions. The governing law and venue for this Agreement are those of the State of Oregon.
